The chapter has taken the first step toward a successful rush in 2009 by electing another outstanding Rush Team: Head Rush Chairman **Rick**

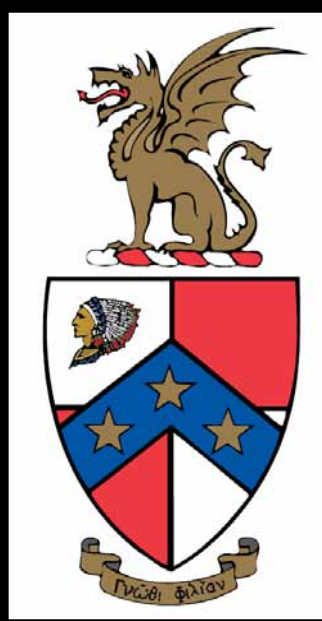

SUE OVERTON NAMED HOUSE MOTHER OF THE YEAR AT 2008 GENERAL CONVENTION

At the General Fraternity's 2008 General Convention, Gamma Phi's house mother, Sue Overton, was named **Beta Theta Pi House Mother of the Year**. Sue first became Gamma Phi house mother in 1997. In the ensuing twelve years, she has been an invaluable asset to the chapter and is richly deserving of this prestigious award.

When Sue arrived in 1997, Gamma Phi faced many challenges. She also had to confront assorted difficulties associated with food services and support staff. Notwithstanding these challenges, Sue embraced her role with zeal and set upon a mission to raise the level of civility and quality of life at 800 Chautauqua.

Sue's record during her continuing tenure demonstrates magnificent accomplishments. The struggling chapter she found in 1997 has since won four Knox awards and numerous Sisson awards and grown into the largest chapter within the General Fraternity. However, these accomplishments do not do justice to the more intangible - yet equally important - depth of Sue's contributions. Under Sue's supervi-

sion and control, the quality and efficiency of food service and staff operations dramatically increased. She regularly and quite skillfully coordinates day-to-day house maintenance and repairs in a way that has improved the quality of life at the house. She has also raised the level of civility in the house through such measures as reimplementation of formal meals and rules of deportment within the house. Importantly, Sue has additionally played a key role in the revitalization of our parents club. Due to Sue's soft touch and obvious devotion to the Chapter, the parents club has become extremely active and consistently supports Sue in her particular projects at the Chapter house such as providing new furnishings for the house, sponsoring holiday parties, and participating in significant improvements to the grounds surrounding the house.

Sue's talents and accomplishments have not gone unnoticed on the OU campus. She has been recognized as the House Mom of the Year at OU and served as President of the OU House Directors Club.

She regularly counsels numerous other fraternity and sorority house mothers, and she is widely recognized as one of the OU Greek community's most competent and experienced housing directors.

Sue also frequently accompanies Chapter representatives at Beta General Conventions.

Sue's tenure has witnessed an impressive transformation of Gamma Phi from a challenged chapter to a role model chapter. She has undeniably played an indispensable role in this success story. Sue has been a tremendous asset to the Gamma Phi Chapter, and she continues to play a key role in its ongoing achievements.

rush functions in Tulsa, Oklahoma City, Norman, Ardmore, Edmond, Dallas and Houston to name a few. These events allowed last year's rush team to get their foot in the door early and often, and were a key to signing another outstanding pledge class this past fall. This year, the rush team's goal is to have the opportunity to hold 20 alumni-hosted functions between the official start of summer rush on June 1, 2009, and the conclusion of summer rush in mid-August 2009. The team needs to host at least two alumni events each week during the approximate to-week period of summer rush, so many alumni volunteers will be needed.

The present day format of summer rush requires extraordinary efforts on the part of the rush chairmen. Done right, a competitive rush campaign entails substantial financial costs. The rush chairmen and their supporting cast of active members must travel extensively to accomplish the one-on-one contact with rushees that is crucial to a successful rush. It's worth mentioning that there has been a steady increase in the number of highly qualified rushees from out-of-state (especially Texas), and the Chapter's rush efforts can no longer focus on Oklahoma alone.

Historically, our rush chairmen have been required to recruit the major metropolitan areas in Oklahoma and also the smaller Oklahoma cities and towns, which have consistently sent quality young men to the Beta House at OU. In recent years, Texas has been added to the mix for summer rush, and the chapter must become more active "south of the border" to compete with the other top fraternities. Every year there has been an increase in enrollment of Texas freshmen at OU, and more and more Gamma Phi legacies return from Texas to attend OU. Dallas area rush events have become commonplace, and the chapter held its first "official" rush party in the Houston area in 2007.

Needless to say, quality remains an overriding mandate for the chapter's rush objectives. Our actives are keenly aware of the importance of sustaining the chapter's historically high standards in terms of academics, leadership and the like. Winning grades is always their primary goal. Of

course, if it is to realize this goal, the chapter must continue to recruit the best and the brightest rushees. On this note, it is important to mention that many of Beta's rivals have also come to realize the importance of academics and now actively seek to displace Gamma Phi as OU's top academic fraternity. Consequently, the competition for the more gifted rushees has become increasingly stiff. To succeed, our rush chairmen must ratchet up their efforts to respond to this challenge, and they need your support to do so.

This is what we need.

To continue to build on successful rush efforts of the past several years, this year's rush team needs three things: (1) referrals of qualified young men who may be participating in fraternity rush in 2009 (please include, *at a minimum*, name, high school, telephone number, high school GPA and ACT/SAT score); (2) financial contributions to fund the many expenses associated with rush, which begin with phone bills in the early spring and end with new pledge t-shirts handed out on bid night in late August; of course, fuel costs have drastically increased the price of quality rush; and (3) volunteers to sponsor alumni-hosted events during the summer.

Most alumni understand the necessity for referrals and financial contributions, both of which are desperately needed and greatly appreciated. Alumni-hosted functions are certainly not new to rush. Considering that nearly 1,000 young men go through rush each year at OU, it would be impossible for the rush team to meet, much less get to know, even a fraction of the rushees without the benefit of alumni-hosted barbeques.

"What is involved in hosting a summer rush function?" The first thing you should know is that they do not remotely resemble the "beer bashes" of earlier generations. For example, IFC rules prohibit the service of alcohol and the presence of women at these events. Today, these events are much more civil affairs. They are typically casual "backyard" or "poolside" barbeques that take place on an evening selected by the host, generally between Wednesday and Saturday. The functions start around 6:30 p.m. and are usually over by 9:00

p.m. The host typically serves something simple, like burgers or barbeque, although some of our alums have used catering services. Attendees include 10 to 30 rushees who live in the host's area, the rush team, a few other active members, and any other alumni the host chooses to invite. These functions offer a chance for the young men to meet and greet and allow the rush team to interface with many more young men than they could otherwise. They also can be a good excuse for alums to get together with their Beta friends and re-live the "good ol' days" at 800 Chautauqua. If you think you might be interested in supporting rush by hosting a function this summer, please contact me as soon as possible.

THREE SCHOLARSHIPS AWARDED - NEW SCHOLARSHIP ESTABLISHED

Foundation President's Report

Beta Theta Pi Foundation of Oklahoma, Inc. is pleased to announce scholarships awarded to Thomas Jefferson ("TJ") Hutchings, '10, Johnston Kyle Fite, '11, and Christopher Charles Hoch, '11.

TJ Hutchings was awarded a second **Patrick James Frensley Memorial Scholarship** for his outstanding leadership of the Chapter and his continuing service to the Fraternity. TJ served as President of the Fraternity as a junior, after having previously served as Vice President as a sophomore. TJ has also provided continuing service to the University by serving as a Camp Crimson counselor for two years, and by chairing public relations for the Dance Marathon which raised \$58,000 for Children's Miracle Network. TJ is also a Big Brother of the Norman, Oklahoma, Children's Cancer Association, and he is a two-year winner of the IFC Community Service Award.

The **Class of 1959 Scholarship** was awarded to **Johnston Kyle Fite**. Brother Fite is a National Merit Scholar majoring in chemistry. He has maintained a 3.9 grade average and plans to attend medical school. In addition, he is a member of the Alpha Lambda Delta service fraternity, is a member of the Campus Activities Council Winter Welcome Week executive committee, a continuing Volunteer for the Big Event, and a summer 2008 AmeriCorps Member for Project TransFormation. He has also participated in mission trips to inner city Chicago and Nuevo Progreso, Mexico.

The first **Harris Family Scholarship** was presented to **Christopher C. Hoch**. Chris is a James L. Nicholas Scholar at the

University, and has completed his sophomore year with a 3.9 grade point average. In addition, Chris is in the President's Leadership Class and a volunteer in multiple campus activities. 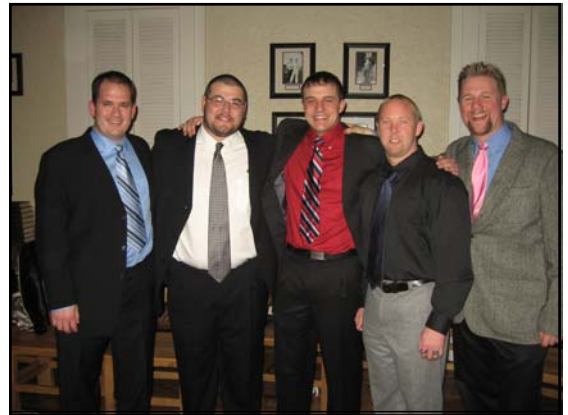


RAUB NASH INITIATED

BETA DONORS PROGRAM OBSERVES 25TH ANNIVERSARY

The 2008-09 Beta Donors campaign was a special one, as it marked the 25th anniversary of the Beta Donors program's founding in 1984.
