

GAMMA PHI SALUTES EARL SNEED: LAWYER, BANKER, LEADER

The Oklahoma Journal salutes Earl Eneed, banker, lawyer, thinker and man of action in Oklahoma. Sneed, former dean of OU's law school, is now a prominent city banker. His court-reform plan has brought him name to every hamlet in the state.

Earl Sneed is a most unusual man and outstanding Beta. He has an exceedingly keen and interpretive mind, together with a warm personality and a genuine interest in people. He has succeeded in whatever he has attempted, and his name has become a byword in the state. For sixteen years he served as Dean of the University of Oklahoma law school, and was a law teacher at the University for twenty years.

Earl Sneed was born in Tulsa in January, 1913. His father, Earl Sneed, was a lawyer. In fact the Sneeds are proud of the fact, that although this is a young state, there is a third generation of Sneeds practicing law in Tulsa.

What makes the Sneed family all the more interesting is that his father, wife, son and daughter all have law degrees from Oklahoma University. Needless to say he was steeped in law and Oklahoma University tradition.

Earl Sneed went to public school in Tulsa. Even in high school his leadership ability was predominant. He was business manager of the high school annual.

Sneed was in the high school senate, president of his sophomore class and active in dramatics and speech. While in college he became interested in ROTC and became a cadet colonel. In college he was also business manager of the college manual, and a member of Phi Beta Kappa. He also belongs to the Order of the Coif which is an organization consisting of those in the upper 10 per cent of their law class.

The same quest of adventure and knowledge was always with him. Between his freshman and sophomore years he and a friend built boat and drifted down the Arkansas River to New Orleans during their 28 days of full adventure.

He received his A.B., L.L.B., and Master of Laws at the University of Oklahoma. He then went on to Columbia University where he received a Doctor of Science of Laws. He married his wife Cornelia while going to law school, at a time when there were very few married students.

In 1941 Earl Sneed was called to active duty as a first lieutenant in the U.S. Army Air Corps which was a branch of service relatively strange to him. He served 35 months overseas in England and North Africa in the Air Service Command. In October, 1944 at the age of 31 he was made a full colonel. Wherever he went his leadership ability led him to positions of authority and responsibility, as it has been proven time and again, a leader in one situation is capable of leading in any situation. He won the Bronze Star, Croix de Guerre, Air Force Commendation Medal, EAME Campaign Medal and three Bronze Stars among other military honors.

When he returned from service he decided he wanted to teach because he liked and enjoyed teaching, and he was accepted to fill the positions of a law teacher. He feels his years as a faculty member and teacher were most interesting and rewarding. His fond memories of his associations and lasting friendships he counts among his greatest satisfaction in teaching, and watching those he taught go on to successful legal, business, and government careers. His personal and lasting friendships with former students are too numerous to mention.

His civic interest and achievements are also wide and varied. He served as Mayor of Norman for two terms. He is past president of the Cleveland County Cancer Society, Norman's Lion's Club; was chairman of the Cleveland county Heart Fund, former director on the Norman Chamber of Commerce and the United Fund.

He is a director of the Sunbeam Home, Oklahoma State Heart association, Will Rogers Memorial commission. He is on the executive committee of the Community Council, Mental Health, and Oklahoma Health Sciences Foundation. He is director of the Oklahoma City Symphony, Better Business Bureau, Gov. Bellmon's Commission on the Judiciary, Trustee of the Oklahoma Art Center and Oklahoma City University Foundation.

On December, 1964, Earl Sneed resigned as Dean of the Oklahoma University Law School and accepted the present position with Liberty National Bank. To him it represented a new challenge, another horizon to be learned and conquered.

Earl Sneed will never stop working with and for others. Challenges keep him eternally young in mind and spirit. His personal satisfaction and pride is in the part he has played in helping others succeed.





Brother Cy Nelson shipped us a deer from San Antonio where the poor animal had frozen to death. Cy probably had some "anti-freeze" in his radiator.

We have a very efficient Frigidaire system — no heat — pipes are bursted — no hot water — Thweat's beard is terrible and nobody else has shaved.

All of the windows in the dormitories are without panes, and nearly everybody moved mattresses into their rooms. We had to sprinkle cold serum all over the house in order to get it warm.

4 January 1928

Noble stayed up all night so he wouldn't miss the early morning train to Ames, where the Sooners engage the boys in a basketball game Thursday.

We had the first cut of venison at lunch, and the College Shop sales were diminished considerably for the noon hour.

Brother Harry Diamond was a visitor and brought approved plans for the new house. The contract was let to Earl Tankersley, a former member of this chapter.

5 January 1928

At last the water is running and Pearson got to take his bath — he's been very cross for a couple of days.

Starkey and Caldwell did a little broadcasting over W.N.A.D. and got over real well for a couple of scrubs.

The Sooners trimmed Ames 51 to 32 — one more game toward a valley title.

6 January 1928

Stroud wrote a couple of letters but got them into the wrong envelopes, which made things tough. The cotton market took a big jump, and oil stock went way

down. Stroud should be able to arrange for enough cotton for undershirts enough oil for "bear grease" to last him the rest of his life.

The Sooners took Drake down the hill again, making it five straight. Noble was in there.

7 January 1928

Brothers Harris and Johnson, as usual, brought guests for lunch. We might add that Brother Elmer Gardner was on the entertainment committee.

Members of Delta Vita went over for a little club work. Brother Colbert has certainly been nice to us — he has pledged about three-fourths of the boys at our house.

Muldrow had another payment on the Canadian bridge at Purcell. He will be sole owner in about a month.

8 January 1928

Brother Cy Nelson dropped in on us and signified his intention of staying with us the second semester. Incidentally he got to eat part of that deer which he sent about a week ago.

We had the women folks over to help us enjoy our venison. After the meal, our peerless trio gave a few selections which were just like a bucket of lard — well rendered and plenty smooth.

9 January 1928

Jack Lehnhard took sick with the flu and was unable to go to classes. Perhaps the main reason for his ailment was the approach of several barrel staves.

The weather being nice, and books being set aside for the day, Hill, Oscar Grimes, Burt Smith, Roy Gardner, Weaver, Patten and Turner had a little baseball workout in the yard. It looks like spring and the crack of wood on horsehide sounds plenty good.
